ABOUT SOCIAL VALUE PIONEER MEMBERSHIP

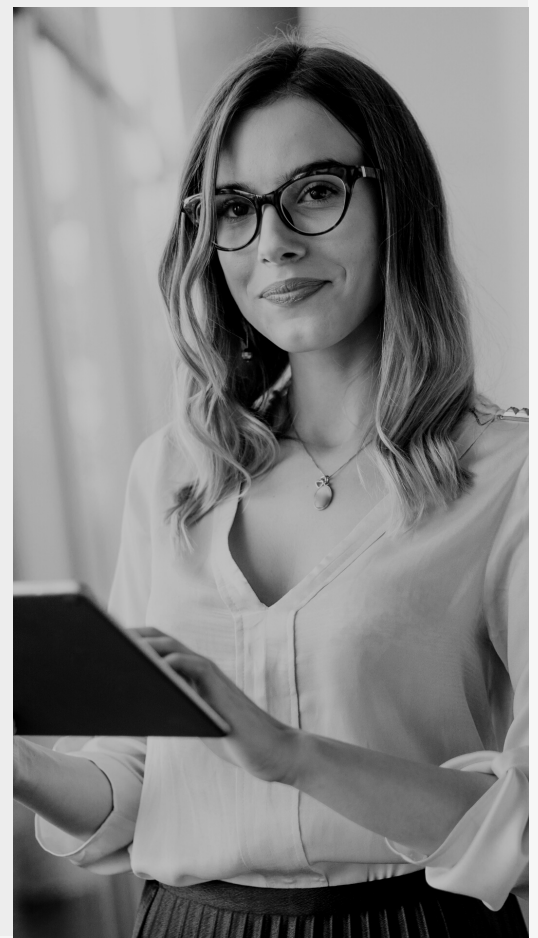
Social Value Pioneer membership is our most popular organisational member package and is open to all organisations who share a commitment to social value.
