WHY HAVE YOU DECIDED TO UNDERTAKE THE SOCIAL VALUE CERTIFICATE ORGANISATIONAL PATHWAY?

The Social Value Certificate provides a robust structure for Trees for Cities to continue its social impact journey. Social impact is complex as it needs to account for subjectivity among our wide range of stakeholders – the support that Social Value UK provides is extremely valuable to ensure that we remain on the right track.

HOW HAVE YOU FORMALISED YOUR COMMITMENT FOR LEVEL ONE OF THE SOCIAL VALUE CERTIFICATE? WHAT PRACTICES OR PROCESSES ARE YOU PUTTING IN PLACE?

We have recruited an Impact Coordinator to lead the charity towards Level Two over the next 12 months. We have also secured commitment and support from our Board of Trustees.

ARE THERE ANY OTHER SPECIFIC PROJECTS YOU ARE DOING AT THE MOMENT THAT ARE RELATED TO SROI/SOCIAL VALUE?

We have launched #GenerationTree campaign to engage people to plant more trees!

We have made a #iwill pledge to deepen our commitment to working with children and young people.

We are also working with Step up to Serve to launch a new pledge for the Year of Green Action in 2019 – watch this space!

We have learnt that we can't make assumptions about the social value of our work. Our perceptions of where our social value lies may be very different from how our stakeholders receive the benefits.
