1. Introduction

Thank you for joining the Advocacy Working Group at the Institute for Social Value (ISV). This group contributes to ISV's mission to advance social value in the UK by:

- Shaping ISV's advocacy and external relations strategy
- Staying abreast of key policy and social value developments, and help co-ordinate ISV's response
- Influencing policy makers and organisations to promote ISV policy goals, address longstanding social value challenges, and facilitate effective social value practice and delivery across a diverse range of sectors

Your input will help inform policy, practice, and collaboration across sectors.

2. Purpose of Working Groups

ISV Working Groups bring together members to help shape thinking, policy, and partnerships in key thematic areas. They are a space for sharing expertise, developing joint work, and progressing ISV's strategic aims.

3. Scope and Responsibilities

The Advocacy Working Group will:

- Guide ISV activity and priorities in advocacy
- Monitor developments relevant to this area and help coordinate ISV's response
- Support the production of campaigns, research, policy recommendations, events, or communications
- · Collaborate with other ISV groups on shared priorities
- Champion integrity, transparency, and inclusion

Group members will:

- · Participate actively in meetings
- Carry out agreed follow-up actions
- Bring relevant knowledge and perspectives to discussions
- Respect confidentiality and the organisation's values

4. Structure and Leadership

- The group will be co-chaired by rotating members of the group, Co-Chairs will sit on the Institute for Social Value Council
- Isabelle Parasram OBE will act as the ISV Strategic Lead, ensuring alignment with ISV's wider strategy
- Co-chairs will lead meetings and help shape agendas
- Sub-groups may be formed to focus on particular projects

5. Meetings and Communication

- Regular monthly virtual meetings, with additional sessions as needed
- One in-person annual session (subject to funding and availability)
- Agendas and joining details will be circulated in advance
- Notes and action points will be shared after each meeting
- Ongoing discussion may take place via Slack.

6. Collaboration

- The Advocacy Working Group may work closely with other groups such as e.g. the Policy and Legislation Group to support cross-cutting initiatives
- Joint projects or meetings may be arranged where aims align

7. Support and Resources

- Induction session and ad-hoc training will be offered
- Administrative and communications support will be provided by ISV staff
- Reasonable travel or participation expenses will be reimbursed
- Members may be invited to represent ISV in public, with prior approval

8. Conduct and Participation

All members are expected to uphold the ISV:

- Code of Conduct
- Conflicts of Interest Policy
- Safeguarding Policy
- Data Protection Policy
- Social Media Policy

These documents will be provided upon joining and are available on request.

9. Time Commitment

Involvement includes:

- One core monthly meeting (60-90 minutes)
- Reading and preparation for meetings
- Participation in project work or sub-groups as relevant
- Occasional additional meetings or events

10. Review and Evaluation

- These Terms of Reference will be reviewed yearly
- Group effectiveness will be monitored as part of ISV's governance
- Feedback is welcomed at any time
